AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWNSHIP OF SOUTH ORANGE VILLAGE, IN THE COUNTY OF ESSEX, NEW JERSEY APPROVING THE  $4^{TH}$  & VALLEY REDEVELOPMENT PLAN PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 ET SEQ.

The **Purpose** of this ordinance is to adopt the proposed Amended Redevelopment Plan presented by the Village Planners Topology, LLC, with regards to parcels identified on the tax maps of the Township of South Orange Village (the "**Village**") as  $4^{th}$  Street at Valley Street South Orange, NJ Block 2303, Lots 7, 8, 9, 10 + 11, which were also designated by the South Orange Planning Board as "an area in need of redevelopment" pursuant to the Redevelopment Law; and
