

THE TOWNSHIP OF SOUTH ORANGE VILLAGE

ORDINANCE #2024-23

The above ordinance, summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of South Orange Village, in the County of Essex, State of New Jersey, on November 25, 2024. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the virtually utilizing the Cisco WebEx Audio/Video System in the Village on December 23, 2024 at 7:00 o'clock p.m. Please monitor the Village's website at www.southorange.org, or please contact the Village Clerk's Office either by telephone at (973) 378-7715, ext. 1, or by email at clerksoffice@southorange.org for instructions on how to access to the meeting. The Village Council may adjourn the public hearing of this Ordinance to a date after December 23, 2024, without any further notice. The following ordinance was introduced:

2024-23 AN ORDINANCE AUTHORIZING HANDICAPPED PARKING FOR NANDI BARNHARDT AT 65 RANDOLPH PLACE, SOUTH ORANGE, AND THE AMENDMENT OF CODE CHAPTER 340-38, SUBSECTION B.

WHEREAS, pursuant to NJSA 39:4-197.6 and South Orange Village Code Chapter 340-38, handicapped parking may be authorized on public roadways; and

WHEREAS, Nandi Barnhardt has been designated handicapped by the New Jersey Motor Vehicle Commission, residing at 65 Randolph Place.

NOW, THEREFORE, BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1. A single car parking space, directly in front of 65 Randolph Place is hereby designated as a handicapped parking space, specifically for Nandi Barnhardt, having been issued Permit P2913280.

SECTION 2. South Orange Code Chapter 340-38, Subsection B is hereby amended with an alphabetic addition as follows:

SECTION 3. This ordinance shall take effect upon final passage and publication as required by law.

SECTION 4. On passage this ordinance shall not be codified, other than the amendment of Code Chapter 340-38, Subsection B.
