ORDINANCE #2026-02

Introduction: January 26, 2026

Adoption:

AN ORDINANCE OF SOUTH ORANGE VILLAGE, APPROVING AND ADOPTING AN UPDATED MUNICIPAL CODE, FULLY INCLUDING ALL ORDINANCES ENACTED THROUGH DECEMBER 31, 2025.

WHEREAS, whereas the Village Code consists of two components. The Online Code, constantly upgraded by Village Counsel as ordinances are adopted, and an annual Hard Copy, prepared by Village Counsel once authorized by the Village Council; and

WHEREAS, all ordinances found to be fully adopted by the Village Clerk and delivered to the Village Counsel, have been promptly posted on the Online Code by the Village Counsel; and

WHEREAS, once authorized by the Village Council, as so authorized by this ordinance, Village Counsel provided the Village Clerk with a Hard Copy of the Village Code; and

WHEREAS, the Village Clerk attaches newly enacted ordinances to the Hard Copy until such time as a new Hard Copy is delivered by Village Counsel; and

WHEREAS, the Village Clerk maintains the Hard Copy for inspection and purchase, by anyone wishing to do so; and

WHEREAS, the Village Council has now determined to enact this ordinance updating the Village Code, so that it officially contains all ordinances enacted since December 31, 2025.

NOW THEREFORE BE IT ORDAINED, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

SECTION 1.

All ordinances enacted through December 31, 2025, all listed on the attached Exhibit, do hereby become part of the Village Code.

SECTION 2.

Village Counsel is hereby authorized and directed to produce a Hard Copy, of the Village Code, for delivery to the Village Clerk.

SECTION 3.

This ordinance shall take effect upon final passage and publication as required by law.



SECTION 4.

On passage, this ordinance shall NOT be codified, but a copy shall always be attached to the Hard Copy maintained by the Village Clerk.
