

**SOUTH ORANGE VILLAGE**

**ORDINANCE #2026-01**

The above ordinance, summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of South Orange Village, County of Essex, State of New Jersey, on January 26, 2026. It will be further considered for final passage, after public hearing thereon, at a meeting of the Governing Body to be held on February 23, 2026, at 7:00 p.m. at the Baird Community Center, 5 Mead Street, 3<sup>rd</sup> Floor Meeting Room, South Orange, NJ. This meeting will be conducted in a hybrid format, with virtual access available via the Zoom Audio/Video System. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be available at no cost and during regular business hours at the Clerk's Office for the members of the general public who shall request the same. The Village Council may adjourn the public hearing of this Ordinance to a date after February 23, 2026, without any further notice. The following ordinance was introduced:

**TITLE: AN ORDINANCE AUTHORIZING HANDICAPPED PARKING FOR GWENDOLYN MELVIN-FOSTER RESIDING AT 119 SETON PLACE, SOUTH ORANGE, AND THE AMENDMENT OF CODE CHAPTER 340-38, SUBSECTION B.**

**WHEREAS**, pursuant to NJSA 39:4-197.6 and South Orange Village Code Chapter 340-38, handicapped parking may be authorized on public roadways; and

**WHEREAS**, Gwendolyn Melvin-Foster has been designated handicapped by the New Jersey Motor Vehicle Commission, and resides at 119 Seton Place.

**NOW, THEREFORE, BE IT ORDAINED**, by the Village Council of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

**SECTION 1.** The single car parking space in front of 119 Seton Place, is hereby designated as the handicapped parking space for Gwendolyn Melvin-Foster having been issued Permit P2984303.

**SECTION 2.** South Orange Code Chapter 340-38, Subsection B is hereby amended as follows:

**SECTION 3.** This ordinance shall take effect upon final passage and publication as required by law.

**SECTION 4.** On passage this ordinance shall not be codified, other than the amendment of Code Chapter 340-38, Subsection B.
