

TOWNSHIP OF SOUTH ORANGE VILLAGE

**RESOLUTION AUTHORIZING DISPOSAL OF VILLAGE VEHICLES AND
EQUIPMENT NO LONGER NEEDED FOR PUBLIC USE**

WHEREAS, N.J.S.A. 40A:11-36 authorizes a municipality to sell or dispose of personal property no longer needed for public use by resolution of its governing body; and

WHEREAS, N.J.S.A. 40A:11-36 provides that if the estimated value of the property to be sold exceeds 15 percent of the bid threshold in any one sale, it shall be sold at public sale to the highest bidder, and, if the estimated value of the property to be sold does not exceed the applicable bid threshold in any one sale, it may be sold at private sale without advertising for bids and or disposed of; and

WHEREAS, the Department of Public Works has determined that certain vehicles are no longer needed for public use and have no value; and

WHEREAS, the Village Purchasing Agent and Village Clerk request approval to dispose of such equipment in accordance with N.J.S.A. 40A:11-36; now,

THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township South Orange Village that it hereby authorizes the Purchasing Agent and Village Clerk to dispose of the following vehicles no longer needed for public use:
