## **RESOLUTION #2021-058**

**RESOLUTION AWARDING A ONE (1) YEAR CONTRACT EXTENSION TO CITY FIRE EQUIPMENT COMPANY INC., IN THE AMOUNT NOT TO EXCEED \$7,560.00 FOR THE ANNUAL CONTRACT FOR FIRE AND BURGLAR ALARM INSPECTIONS, AUTOMATED EXTERNAL DEFIBRILLATOR INSPECTIONS, CENTRAL STATION MONITORING AND INSPECTION, TESTING OF FIRE EXTINGUISHERS AND SUPPRESSION SYSTEM INSPECTIONS FOR VILLAGE BUILDINGS**

WHEREAS, bid specifications were prepared for an Alarm Monitoring & Inspection Services Contract; and

WHEREAS, the 2016 Alarm Monitoring & Inspection Services Contract had a 3 year contract option and two (1) year extension options upon Village recommendation and contractors approval; and

WHEREAS, it is recommendation of the Village Engineer that the option to extend the contract for Alarm Monitoring & Inspection Services with City Fire Equipment Company, Inc., 733 Ridgedale Avenue, Suite 203, East Hanover, NJ 07936; and

WHEREAS, the annual cost for the central station monitoring is not to exceed \$3,080.00; and

WHEREAS, the annual cost for inspections and testing of fire extinguishers is not to exceed \$600.00; and

WHEREAS, the annual cost for inspections and testing of fire alarm systems is not to exceed \$2,850.00; and

WHEREAS, the annual cost for inspections and testing of the wet sprinkler system is not to exceed \$515.00; and

WHEREAS, the annual cost for inspections and testing of the suppression systems is not to exceed \$515.00; and

WHEREAS, the sum of the annual costs of these services is not to exceed \$7,560.00; and

WHEREAS, City Fire Equipment Company, Inc., will have the contract for the 2021 calendar year;



WHEREAS, City Fire Equipment Company, Inc. is considered a responsible bidder;

WHEREAS, the Board of Trustees of the Township of South Orange Village does concur with the recommendation;

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of the Township of South Orange Village that it hereby authorizes an award of contract to be made to City Fire Equipment Company, Inc., 733 Ridgedale Avenue, Suite 203, East Hanover, NJ 07936 to provide services for the fire and burglar alarm central station monitoring and inspection and testing of fire extinguishers for village buildings pursuant to their proposal, annexed hereto and made a part of this Resolution.
