**RESOLUTION AUTHORIZING WAIVER OF APPLICATION FEES FOR SIDEWALK SALE/
OUTSIDE DISPLAY PERMITS & AL FRESCO DINING PERMITS UNTIL DECEMBER 31, 2021
OR UNTIL THE VILLAGE PRESIDENT LIFTS THE LOCAL STATE OF EMERGENCY;
WHICHEVER SHALL BE SOONER**

WHEREAS, Section 305-38 authorizes the Village Clerk's Office of the Township of South Orange Village to issue Sidewalk Sale/Outside Display Permits following the adoption of an enabling resolutions; and

WHEREAS, Section 305-40 authorizes the Director of the Department of Code Enforcement to issue licenses to owners of qualified businesses who apply and meet the criteria as established by the Village Code for the Township of South Orange Village during the periods of time authorized by the Board of Trustees that businesses are allowed to operate Sidewalk Sale/Outside Display Permits and Al Fresco Dining Permits; and

WHEREAS, it is required that licensees shall pay a fee for the issuance of Sidewalk/Outside Display Permits and Al Fresco Dining Permits; and

WHEREAS, to continue to assist local businesses, the Township of South Orange Village has determined it to be appropriate and in the best interest for local businesses to waive the fees charged for the issuance of Sidewalk Sale/Outside Display Permits & Al Fresco Dining Permits up to and including December 31, 2021 or until such time that the Village President may lift the present Executive Order of the Village President declaring a local State of Emergency; whichever shall be sooner.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of South Orange Village that it hereby authorizes the waiver of the fees charged for issuance of Sidewalk Sale/Outside Display Permits & Al Fresco Dining Permits.
