RESOLUTION ACCEPTING PROPOSAL OF AND AWARDING CONTRACT TO OMEGA ENVIRONMENTAL SERVICES INC. FOR NON-OCCUPIED SUB-CHAPTER 8 ASCM MONITORING

WHEREAS, the Township of South Orange Village (the "Village") has a need for non-occupied sub-chapter 8 ASCM Monitoring for the Baird Center, 5 Mead Street during asbestos remediation; and

WHEREAS, the Village Administrator has recommended the award of a contract to OMEGA Environmental Services Inc. for this monitoring during Asbestos removal at the Baird Center, 5 Mead Street during the remediation in accordance with the attached proposal.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of South Orange Village that it hereby accepts the attached proposal of, and authorizes the award of a contract to Omega Environmental Services, Inc. in accordance with the attached proposal in the amount not to exceed \$20,570.00; and

BE IT FURTHER RESOLVED that the Village President or Village Administrator and Village Clerk are hereby authorized to execute a contract for said purchase upon receipt of an executed Certification of Available Funds from the Village's Treasurer.


