## **ORDINANCE #2021-06**

**Introduction: February 22, 2021**

**Adoption: March 22, 2021**

**AN ORDINANCE AMENDING THE VILLAGE CODE, CHAPTER 305, "DUTY OF OWNER OR TENANT TO REMOVE", BY ADDING SUBSECTION C IMPOSING PENALTIES FOR THE FAILURE TO REMOVE SNOW OR IMPROPER REMOVAL OF SNOW**

**BE IT ORDAINED**, by the Board of Trustees of the Township of South Orange Village, a municipal corporation of New Jersey located in Essex County thereof, as follows:

### **Section 1.**

Section 305-1, "Duty of Owner Or Tenant To Remove" is hereby amended by the addition of the following entry:

C. Violators of this Section (Section 305-1) will be subject to the following penalties:

<b>Description</b>	<b>Penalty</b>
<b>Penalty of Owner or Tenant for failing to Remove snow or improperly removing same in connection with snow events in following amounts of accumulation*:</b>	*Accumulation will be verified from the National Weather Service to determine the number of inches for the snow event in question
0-3 inches	\$300.00
3-6 inches	\$600.00
6-12 inches	\$1200.00
Over 12 inches	\$1200.00 plus \$100 per inch

### **Section 3.**

Repealer

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.



**Section 3.**

This ordinance shall take effect after final passage and publication as required by law.

**Section 4.**

On passage this ordinance shall be codified.
