RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO VAN CLEEF ENGINEERING ASSOCIATES FOR PROFESSIONAL ENGINEERING SERVICES FOR THE TOWNSHIP OF SOUTH ORANGE VILLAGE, IN THE AMOUNT NOT TO EXCEED \$33,000.00

WHEREAS, there exists the need for the services of a professional engineering company to provide necessary support services for the Township of South Orange Village on a as needed basis; and

WHEREAS, a RFQ was advertised and ten (10) proposals were received on June 22, 2021; and

WHEREAS, the Village Administrator has reviewed the proposals and interviewed Van Cleef Engineering for the proposed services; and

WHEREAS, the Village Administrator recommends awarding a contract for these services to Van Cleef Engineering Associates; and

WHEREAS, the Board of Trustees does concur with the recommendation of the Village Administrator to hire the firm of Van Cleef Engineering Associates, 111 Howard Boulevard, Suite 110, Mt. Arlington, NJ 07856, to provide professional engineering services for the Township of South Orange Village in accordance with their proposal dated June 18, 2021; now,

THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Township of South Orange Village, that the Village President and Village Clerk are hereby authorized to execute an agreement between the Township of South Orange Village and Van Cleef Engineering Associates, in an amount not to exceed \$33,000.00; and

BE IT FURTHER RESOLVED, that the fees to be charged are in accordance with the proposal submitted for this project, annexed hereto and made a part of this resolution.
