RESOLUTION CREATING AD-HOC ADVISORY COMMITTEE WHICH SHALL BE KNOWN AS THE SOUTH ORANGE CANNABIS TASK FORCE

WHEREAS, the Township of South Orange Village (the "Village") enjoys and encourages robust engagement of its residents as it concerns local governance and local concerns; and

WHEREAS, the Village wishes to further encourage the engagement of its citizens as it concerns the recent legalization of recreational marijuana cultivation, distribution and retail sales; and

WHEREAS, the Board of Trustees would benefit from input from the community as it concerns local decisions regarding possible cultivation, distribution and retail sales of cannabis and cannabis products in the Village and wishes to create an ad-hoc advisory committee which shall be known as the South Orange Cannabis Task Force; and

WHEREAS, the South Orange Cannabis Task Force enables community discussion and can advise Village Administration and government officials; and

WHEREAS, Chapter 3, Section 8 of the Village Code provides for the creation of an ad-hoc advisory committees by the Board of Trustees upon adoption of a resolution establishing same; and

WHEREAS, the Village President supports the Board of Trustees' creation of the South Orange Cannabis Taskforce

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of South Orange Village that:

- 1. There is hereby established and deemed to exist an ad-hoc advisory committee known as the South Orange Cannabis Task Force which ad-hoc advisory committee shall conform to the requirements of Village Code Chapter 3, Section 8 in its formation, membership and operation.
- 2. Within 30 days of the adoption of this resolution, the South Orange Cannabis Task Force shall create, and the Village President and/or the



Board of Trustees shall file with the Village Clerk, a formation document which shall include the following:

- a. recommended membership according to Chapter 3, Section 8(C);
- b. Expected duration from creation or date after which it will cease to exist unless further extended as required by Chapter 3, Section 8(B);
- c. Identification of members and designations as required by Chapter 3, Sections 8(C) and 8(D); and
- d. Commitment to comply with Chapter 3, Sections 8(E) and 8(F).
