RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) 2021 HYBRID FORD ESCAPES, SE MODEL FOR THE HEALTH DEPARTMENT AND RECREATION DEPARTMENT THRU ENTERPRISE FLEET MANAGEMENT UNDER THE SOURCEWELL COOPERATIVE PRICING COUNCIL CONTRACT #060618-EFM IN THE AMOUNT NOT TO EXCEED \$63,274.19

WHEREAS, the Township of South Orange Village wishes to purchase two (2) 2021 Hybrid Ford Escape vehicles, model SE from an authorized vendor under the SOURCEWELL Cooperative Pricing Council, **CONTRACT #060618-EFM**; and

WHEREAS, Enterprise Fleet Management has been awarded **CONTRACT #060618-EFM**; and


WHEREAS, the Village Administrator has recommended the acquisition of two vehicles pursuant to the SOURCEWELL Contract; now,

THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of South Orange Village that the Board hereby authorizes and approves the purchase of two 2021 Hybrid Ford Escapes model SE vehicles through SOURCEWELL Cooperative Pricing Council, **CONTRACT #060618-EFM**, to Enterprise Fleet Management, in a total amount not to exceed **\$63,274.19**; and
