RESOLUTION AUTHORIZING THE APPOINTMENT AND HIRING OF RYAN PAGANO AS THE FULL-TIME RECREATION LEADER IN THE DEPARTMENT OF RECREATION AND CULTURAL AFFAIRS FOR THE TOWNSHIP OF SOUTH ORANGE VILLAGE

WHEREAS, the Director of the Department of Recreation and Cultural Affairs has recommended the appointment of Ryan Pagano as the full-time Recreation Leader in the aforementioned department.

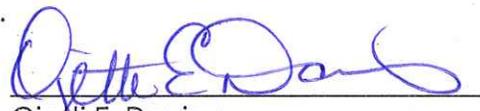

Exhibit A

The terms and conditions of employment upon which Mr. Pagano is appointed are as follows:

- **Position:** Recreation and Cultural Affairs – Recreation Leader
- **Start Date:** September 13, 2021
- **Hours of Work:** Full time position, M – F 8:30 – 4:30 with occasional nights and weekends for meeting and events.
- **Annual 2020 Salary:** \$ 50,000 annually (pro-rated from start date)
- **Health Insurance:** Shall be limited to elect enrollment in Blue Cross Blue Shield OMNIA Health Plan, or a similar costing plan if this plan is no longer available, and contribute to the cost of their health insurance as required by Chapter 78. Alternatively, employees may elect in any other plan offered by the SHBP but shall pay the net difference of the employer contribution that is greater than the OMNIA Health Plan plus their Chapter 78 contribution. (Commences 60 days after employment)
- **Dental Insurance:** Full family dental coverage the same as all other full time employees, subject to any standard waiting period.
- **Vacation:** 1 day per month for the first year and 15 days thereafter.
- **Sick Leave:** 15 days per year.
- **Holidays:** 12 Holidays per year
