RESOLUTION AMENDING RESOLUTION 2021-197 WITHDRAWING THE RENEWAL OF THE LIQUOR LICENSE OF EDEN CAFÉ & DINER UNTIL AUTHORIZATION FROM THE STATE OF NEW JERSEY DIVISION OF ALCOHOLIC BEVERAGE CONTROL PERMITTING LOCAL APPROVAL

WHEREAS, renewal applications were made to the Township of South Orange Village, County of Essex (the "Village"), for the renewal of liquor licenses for the 2021-2022 license term; and

WHEREAS, the renewal application of the Eden Café & Diner was complete in all respects insofar as local processes were concerned and as certified to by the Village Clerk; and

WHEREAS, the Village adopted Resolution 2021-197 approving the renewal and issuance of, among others, the liquor license for Eden Café & Diner for the 2021-2022 license term; and

WHEREAS, the Village Clerk has been advised by the State of New Jersey Division of Alcoholic Beverage Control that the renewal application of Eden Café & Diner requires additional processing on the part of the State and that the renewal granted by the Village must be withdrawn until the State completes processing the Eden Café & Diner renewal application and any special permissions attached thereto; and

THEREFORE, BE IT RESOLVED that the Board of Trustees of the Township of South Orange Village that Resolution 2021-197 is hereby amended insofar as the renewal of Plenary Retail Consumption License 0719-33-005-003 for Eden Café & Dining for the 2021-2022 license term is withdrawn until the Village is advised by the State of New Jersey Division of Alcoholic Beverage Control that the State has completed processing the Eden Café & Diner renewal application and any special permissions attached thereto; and

BE IT FURTHER RESOLVED that Resolution 2021-197 shall remain in full force and effect in all other regards and the renewal of Plenary Retail Consumption Licenses 0719-33-001-006 for 101 South Orange Avenue Operations, LLC and 0719-33-012-



010 for DM Restaurant Ventures LLC t/a The Fox and Falcon remain in full force and effect.
