AN ORDINANCE AUTHORIZING THE BOARD OF TRUSTEES TO FILE A PETITION WITH THE LEGISLATURE OF THE STATE OF NEW JERSEY FOR THE ADOPTION OF A SPECIAL LAW TO AUTHORIZE THE AMENDMENT OF THE SPECIAL CHARTER GOVERNING THE TOWNSHIP OF SOUTH ORANGE VILLAGE

BE IT HEREBY ORDAINED AND ENACTED by the Board of Trustees of the Township of South Orange Village, County of Essex, as follows:

Section 1.

1. Pursuant to the provisions of N.J.S.A. 1:6-10 et seq., the Board of Trustees of the Township of South Orange Village shall be and is hereby authorized and directed to petition the Legislature of the State of New Jersey, pursuant to the annexed petition, for the passage of a special law to amend the Charter as described in the proposed draft of the revised Charter also annexed hereto and made a part hereof. More specifically such amendments include changing the name of the “Township of South Orange Village” to “South Orange Village”, changing the name of the governing body from the “Board of Trustees” to “Council”, changing the titles of members of the governing body from “Village President” and “Trustee” to “Mayor” and “Council Member”, replacing the office of Village Treasurer with Chief Financial Officer, to make technical changes to conform with State law, including options for election dates and stipends for elected officials, and to eliminate the sole use of male pronouns.
2. The Village President and other officers and employees of the Township of South Orange Village are hereby authorized and directed to take all the steps which may be necessary for the proper enactment of said law and the Village President, Village Administrator and Village Clerk are hereby authorized and directed to execute any and all documents necessary to that end.

Section 2.

This Ordinance shall take effect 20 days after final passage and publication according to law.

Section 3.

On passage this ordinance shall not be codified.
